Work progress and achievements in 2018

- A challenging year
- Increased number of investigations and enquiries completed
- Support for auditor regulatory reform
- Strengthened the collaboration with the Mainland and international regulators
- Regular communications with audit firms, professional bodies and media

Auditor Regulatory Reform

- Support 7 Bill's Committee meetings – research and analysis papers
- Stakeholder engagement
 - 9 presentations to 46 audit firms that audit listed companies
 - 9 media interviews (84 clippings) and 2 meetings with academic columnists
 - Provided updates to 5 professional bodies

Strengthening Regulatory Collaboration

- Quarterly meetings with SFC, HKEX and HKICPA
- Courtesy visit to MoF - Signing Ceremony of MOU in May 2019
- Participation in regional regulators meetings
- Meeting with IFIAR
