## Personal Data (Privacy) Ordinance

Your complaint may include personal data as defined in the Personal Data (Privacy) Ordinance (Cap 486) (the PDPO). Under the PDPO, the AFRC may collect and use personal data to perform its functions as a financial regulator.
